**CAMPERSHIP FOR GERALD R. FORD COUNCIL YOUTH MEMBERS**

A sum of money has been made available to assist needy registered members of the Gerald R. Ford Council to attend a summer camping experience. To be eligible for this financial assistance, the youth must be:

1. Registered and in good standing in his unit for at least 30 days prior to filing application.
2. In need of some financial assistance in order to attend camp.
3. Recommended for this financial assistance by his unit leader.
4. Participate in our "Council Popcorn Sale" and Spring "Earn Your Way to Camp" sale.

We appeal to you to help us award these camperships to deserving youth members of the Gerald R. Ford Council. Will you and your committee review the youth in your unit and make recommendations? An application should be submitted for each individual you feel is in need of financial help. Additional applications are available from the DeVos Family Center for Scouting. Applications are to be kept confidential.

It is our belief that each individual applicant should try to pay some portion of his fee and that his unit or chartered partner should also pay a portion of the camp fee. The applicant's parents and unit leader should sign the front of the campership application committing their portion of the fee, which is one half the regular fee for the camp applied for. Please see our Spring "Earn Your Way to Camp" popcorn sale information for full campership program details.

Applications for camperships must be made in writing, using the Council "Campership Application" and **must be made prior to April 15th and not accepted after June 1st.**

If awarded, the campership will be sent to the unit leader. The balance of any fees due must be paid by any applicable due dates.

We desire that all camperships be awarded with a minimum of publicity in order that the applicants who are recipients are not embarrassed. We do expect a thank you note and photo from camp of recipient be sent to us.

This application for financial aid is to be completed by the applicant's unit leader and sent to the Gerald R. Ford Council, Boy Scouts of America, 3213 Walker Ave. NW, Grand Rapids, MI 49544-9775.
